2. If selected, I understand I must have at least a 2.5 GPA to receive any scholarship money for being a Ranger Cheerleader or Mascot.
3. If selected, I understand that I am required to have a physical performed by the school athletic trainer prior to the 2009-2010 school year in order to be covered by NWOSU medical insurance, which covers only injuries received during supervised cheerleading activities.
4. If selected, I will attend all scheduled practices, classes, performances, summer camp, fundraisers and other designated functions/duties assigned by the coach.
5. I agree to follow all safety guidelines deemed necessary by the coach.

I understand and accept that failure to meet any of the above items will result in my disqualification from consideration/participation. I also agree that if selected, I will fully abide by the NWOSU Ranger Cheerleading Squad/Mascot rules and regulations both stated and not stated in the contract.
