Dissertation, "The Progression of Dirt in Victorian Literature"

In my foray into dirt studies, I have drawn upon the works of several scholars who associate dirt with themes of social anxiety, class, control, and order, and I extend their research by arguing that Victorian culture is divided by its proximity to dirt and that until it (dirt) is assimilated into the nation's economy as commodity, it will continually offend the established order of culture and further perpetuate national anxiety and prejudice.

Thesis, "Exploring Nature in the World of Fantasy Literature"

This thesis examines the Secondary World of seven fantasy texts, J.K. Rowling's *Harry Potter* series, C.S. Lewis's *Narnia* series, Phillip Pullman's *The Golden Compass*, J.R.R. Tolkien's *The Hobbit*, Ursula LeGuin's *The Wizard of Earthsea*, L. Frank Baum's *The Wonderful Wizard of Oz*, and Lewis Carroll's *Alice in Wonderland*, and argues that nature in the Secondary World of fantasy literature functions as an escape, a scene for carnival, a prison, or a cover for evil. The thesis provides an ecocritical reading of the fantasy world of these texts, and explains how "nature" works to progress the plot of the texts.
