The principal or superintendent from the contestant's school <u>must certify</u> the contestant on the <u>Certification</u> <u>of Local Winner form</u> to be considered entered in the pageant. This form is due by <u>Wednesday, September</u> <u>6</u>, with no exceptions. The pageant is limited to the first 36 schools that certify their local winners. <u>The</u> <u>Contestant's Information and Data Sheet with media release are also due by Wednesday, September 6</u>.

For your convenience, the <u>Certification of Local Winner form</u> and the <u>Contestant's Information and Data</u> <u>Sheet</u> with its instructions and media release are enclosed. The <u>Miss Cinderella Pageant 2017 Rules</u> are also provided. It is expected that all contestants will access and be familiar with all of the provided documents. <u>The time limit for talent is 1 ½ minutes (90 seconds)</u>.
