Miss Northwestern's Outstanding Teen

Competition Rules

Eligibility

1. Must not be older than 18 years old on December 31st, 2023.
2. Must be at least 13 years old on the first day of the Miss Oklahoma's Outstanding Teen Competition (by June 4th, 2023).
3. Candidate must be a citizen of the United States.
4. Candidate must not now, nor have ever been married, nor be a parent or adoptive parent.
5. Candidate must be a young lady of the highest moral character, integrity, and standards.
6. Candidate must execute the Candidate Contract and abide by all the agreements and representations contained therein.

Backstage

1. Candidates must do their own hair and make-up. Parents, make-up artists, hair stylists, etc. will not be allowed backstage or in the interview waiting rooms.
2. Hostesses will be available to assist the candidates with their clothing, etc. backstage and in the interview waiting rooms.

Interview

1. Interviews at the local level will be a total of 6 minutes. Interviews will take place with a panel of at least five judges. There will be no opening or closing comments – only questions and answers.
2. Questions will come from a variety of areas, including but not limited to the candidate's application and fact sheet, moral/ethical issues, current events, etc. Candidates should be prepared to answer any type of question asked.
3. Candidate's outfit should reflect her personality and age. This is the first impression you will make on the judges in person! We want to see you in a "teen stylish" outfit. Dress as if you were giving a speech to your student body, interviewing for a job at a trendy boutique, or being introduced as the new class president in front of the entire school. Look professional and confident, but remember, we are a TEEN organization. Pay attention to your shoes. Acrylic platform shoes are not appropriate for an interview.

Evening Wear/On-Stage Question

1. Candidate will be asked one question on stage. Questions can be over any topic.
2. Candidate should wear age appropriate attire that makes her feel confident!
3. Age appropriate full-length gowns are appropriate. Shorter attire may be worn, but must be age appropriate and non-revealing when worn on a stage.

Talent

1. Candidate's talent must not be longer than 90 seconds (1 minute and 30 seconds). Email talent track to plfischer@nwosu.edu
2. "Live" accompaniment is not permitted. Only the candidate is permitted on-stage. No other person may be a part of her presentation though background vocals will be allowed as long as they don't overpower the candidate.
3. Talent must be performed live; pantomime and lip-sync are not permitted.
4. Tap dancers may not have accompaniment talent tracks with pre-recorded taps or tap sounds.
5. The sound engineer will not stop and re-start the track as a part of the candidate's performance. If a candidate needs a ten second delay in her performance, then the CD should include a ten second silent spot.
6. No other tracks may be included on the accompaniment track.
7. Background tracks will be approved by the competition.
8. Fire (fire ropes, fire batons, etc.), pyrotechnics, swords, knives or machetes, bow and arrow acts, and the use of live animals are strictly prohibited.

Active Wear

1. The candidate will wear an active wear item of her choosing. This does **not** include swimsuits. This can be what you would wear to the gym, attire you would wear to participate in a sport, etc. The candidate defines her own personality and style preference. This is to be something that you do in your personal life to stay physically fit. Please email Paige if you need suggestions, examples, or guidance.

Resume Instructions

Please remember this is your opportunity to demonstrate to the judges why they should consider you for the job of Miss America's Outstanding Teen. You may list as many or as few items under each category as you desire. This one page, combined with the Social Impact Initiative Statement, will comprise your entire application for this job. The judges will receive exactly what is submitted. **Please note: Do not put your age on the Resume!**

1. Go to the word processing program of your computer.
2. Start a "new" document
3. Set margins for 1" on all four sides. The font style may not be any smaller than "10" and no larger than "12" point type, using the Times Roman font style. Please refer to the attached sample to verify you are following the requested format.
4. With the justification set for left, type "**Name:**" in **bold**. Following the colon (:), hit the space bar twice. Then, type your name as you wish the judges to know it. (If your name is Mary Deborah Smith and you want to be known as "Deborah Smith", please type "Deborah Smith").
5. Then, move to the next line and type "**Title:**" in **bold**. Following the colon (:), hit the space bar twice. Then, type your state title.
6. Then, move to the next line and type "**Hometown:**" in **bold**. Following the colon (:), hit the space bar twice. Then type your hometown including the city and the state.
7. Double space down. Type "**Education:**" in **bold**. Hit the tab bar three times and then type your most recent school first. List in order with the most recent, all schools attended (Pre-K, elementary, middle, junior high, high school).
8. Double space down. Hit the tab bar once. Type "**Social Impact:**" in **bold**. Hit the tab bar three times. Type the TITLE of your social impact initiative, MAKING SURE IT LINES UP WITH THE INFORMATION ABOVE IT. DO NOT TYPE ANYTHING OTHER THAN THE TITLE.
9. Double space down. Hit the tab bar once. Type "**Scholastic / Career Ambition:**" in **bold**. Hit the Tab bar once, MAKING SURE IT LINES UP WITH THE OTHERS ABOVE IT. Then type the type of degree / education you would ultimately like to achieve and beneath that, list your career ambition.
10. Double space down. Hit the Tab bar once. Type "**Talent:**" in **bold**. Hit the Tab bar three times. Type the type of talent and specific selection. MAKE SURE IT LINES UP WITH THE INFORMATION ABOVE IT. (e.g.: Pop Vocal - "Crying", Tap Dance - "Staying Alive", etc.)
11. Double space down. Type "**Scholastic Honors:**" in **bold**. Hit the space bar twice. Each item should be separated by a semi-colon (;).
12. Double space down. Type "**Leadership Roles:**" in **bold**. Hit the space bar twice. Each item should be separated by a semi-colon (;).
13. Double space down. Type "**Accomplishments:**" in **bold**. Hit the space bar twice. Each item should be separated by a semi-colon (;).
14. Double space down. Type "**Interesting Facts:**" in **bold**. Hit the space bar twice. Each item should be separated by a semi-colon (;).
15. Double space down. Type "**Marketing Plan:**" in **bold**. Hit the space bar twice. In sentence form, explain how you would market the *Miss America's Outstanding Teen* "brand". Please include any relevant experience you have which may uniquely qualify you to serve in this position. Please be aware that a portion of the *Miss America's Outstanding Teen* job description will include marketing the *Miss America's Outstanding Teen* program to potential sponsors, educational institutions, and organizations.
16. Double space down. Type "**Legacy:**" in **bold**. Hit the space bar twice. This should be typed in sentence form. Please write what your legacy, as *Miss America's Outstanding Teen* will be. This statement should answer the question, "A year after giving up your title as *Miss America's Outstanding Teen*, what will we remember about your year of service?"

17. Double space down. Type “***Why should I be Miss America’s Outstanding Teen 20__?***” in bold. Hit the space bar twice. Explain to the judging panel why you should be selected ***Miss America’s Outstanding Teen*** and, more importantly, why you should be selected ***Miss America’s Outstanding Teen*** this year.

Important

Please remember that the entire form MUST FIT ON ONE PAGE using the Times Roman font style. You must leave a 1” margin on all four sides of the page. Use your best judgment on what is most important for the judges to know about you. Use your space wisely. Attached is an example of what this should look like. Any variations from this form will be returned to you and will not be accepted. Your materials will not be retyped. The judges will receive your original work. **CHECK SPELLING AND GRAMMAR!!**

This form will be given to the judges along with your social impact initiative statement. These two pages, will create your entire application. By submitting these forms to the national office you verify that everything on your forms is true and accurate. If it is proven that any information on these forms is not true, correct, and factual, you risk losing your local/state title.

Some spacing issues may arise. Simply follow the example provided (i.e. in some cases you may need to hit the “tab bar” four times instead of three times). Do not attempt to change margins, font, size options, or deviate from the requested criteria as set forth in this document.

Why I should be Miss Oklahoma's Outstanding Teen this year: It is critical that this national face and embrace its cultural diversity issues and it must be done now. The traditional ethnic make-up of our country is rapidly changing and unless we confront and inoculate the potential conflicts that might arise, we are headed to potential racial conflicts we have not seen since the 1960s. These conflicts are generally caused by fear and ignorance. Through a nation-wide spokesperson who can give this issue a face and a voice, we can begin the educational process that needs to take place. The reality is that Miss Oklahoma's Outstanding Teen can have her greatest sphere of influence among our nation's youth. By placing Miss Oklahoma's Outstanding Teen in the midst of our nation's young people and we start the process of changing mindsets and, ultimately, changing the way in which they will treat one another in the future. The issues related to Celebrating Cultural Diversity and Inclusiveness is not just related to race, but also to religion, cultural differences, and sexism. There is no greater role for Miss Oklahoma's Outstanding Teen than to educate, empower, and embrace the issue of cultural diversity at this point in our nation's history.

Celebrating Cultural Diversity and Inclusiveness

It is imperative that this nation face and embrace its cultural diversity. While many people have talked about this issue, I believe that most of them have only paid lip service to the true necessity of what needs to be addressed related to this issue. There is a false truth in merely accepting and tolerating cultural diversity. I intend to prove that in order to accept and understand people of other cultures; one must be willing to step out of a personal cultural comfort zone and identify the origin of their prejudice. I will specifically focus on three areas: Children, Communities, and Businesses.

The title of Miss America, combined with the national media already looking at the surface of this issue, will allow me to create the national awareness that must exist. Currently, the term "Cultural Diversity" is well known in the halls of institutions of higher learner and, perhaps, even in the public school classroom because of the need for some to be politically correct. But, in order for us to make a true change in attitudes and behaviors of Americans, we must move beyond talk and into action and policy changes.

My plan is to motivate the media and to partner with the National Conference for Community and Justice. This organization has chapters in every major city in the nation and, in many cases, those chapters have community leaders involved who can, with encouragement and challenging, bring this issue out of hiding and into the public light in each of those communities.

Obviously the media and the NCCJ already exist. However, what is lacking is a lighting rod to draw attention to this issue. This is where the Miss America Organization steps into the lead. What better role is there for Miss America than to be an agent of change in organizing our nation to accept our differences and to create an environment that values each person on individual characteristics rather than on stereotypes or assumptions?

For years, Miss America was seen as a young woman who cut ribbons and appeared in parades. It is time for "Miss America" to step out of the convertible and *lead the parade*. Our country's ethnic make-up is changing rapidly and our citizen's fear of terrorism can explode already existing, but deeply hidden prejudices. I want to be the leader that this nation needs.

This nation needs this issue addressed now and through the already existing NCCJ and its local and state organizations combined with the power of Miss America, we can make a concrete difference now, which will change the direction and the future of our nation.
