The Baccalaureate/Graduate Degree Board of Commissioners met on April 21, 2023 and approved the business program accreditation for Northwestern Oklahoma State University. Congratulations!

Northwestern Oklahoma State University is fully reaffirmed with notes.

Place a Note on Standard 1, Criterion 1.1.b. The business unit would benefit from tracking and measuring key performance indicators (e.g., recruitment, persistence, retention, completion, placement, etc.) relative to their stated mission, goals, and values.

Place a Note on Standard 1, Criterion 1.1.c. Developing specific goals and measures related to the Business Unit's social and community responsibility, which are more clearly centered on and tied to the Unit's mission, vision, and values may strengthen their position.

Place a Note on Standard 3, Criterion 3.1.d. Expanding the formal engagement of stakeholder groups through a systematic process including surveys, documented meetings, etc. may be beneficial to the business unit.

Place a Note on Standard 5, Criterion 5.3.b. Providing formal processes for evaluating and developing all faculty, including adjunct, may improve outcomes relative to the business unit's mission, goals, values, and student learning objectives.

Place a Note on Standard 6, Criterion 6.1. A formalized process for leveraging business advisory boards (or similar) may benefit the business unit relative to programming currency, relevancy, and value.
