Fall 2019

Karen Sneary attended the Reaching Underserved Students – Online Conference on Attendance Fall 2019.

Karen Sneary also attended the following conferences or events in the Fall of 2019: Cultural awareness, understanding, and sensitivity – Presentation by Dr. Steven Aragon, ODCTE Understanding and recognizing unconscious bias – Day-long Workshop at CVTC by Dr. Shanna Teel. In November 2019, Dr. John Stockmyer was a participant in a (Ph.D. Dissertation-related) depth interview conducted by Dr. Mariann Braten-Hall. The title of the study was: CULTURAL COMPETENCE IN HIGHER EDUCATION FACULTY. The purpose of the study was to investigate "cultural competence in higher education faculty of a rural, public university in the West-South-Central region of the U.S."

The qualitative part of the research found that "participants viewed being open-minded and actively promoting cultural competence in one's environment as pertinent when developing cultural competence. The personal and professional experiences described by faculty as helpful in developing cultural competence included relationships with people from diverse backgrounds, were outside of their regular setting, and included training and support relevant to the experience at hand. The findings of this study indicated a positive correlation between high ISS scores and high interest in further professional development towards cultural competence in higher education faculty. Findings further indicated that personal and professional cultural experiences and encounters contributed to the development of cultural competence in higher education faculty."

Dr. Roger Brown had Allyson Bush owner of the Daisy Village (Alva) as a guest speaker for his Leadership in Business classes and his Principles of Management class in Fall 2019. Some of the topics she discussed included managing a small business, dealing with employees, keeping track of inventory, online presence, and being a female entrepreneur.

Dr. Roger Brown did a review of a paper for the 2020 MBAA International Conference that was titled "A Study of Women Working in Jordanian Banks" at the request of the MBAA International Business Society and Government Consortium Program Chair and of the Division of Business Dr. Wei Zhou. This paper discussed a lot of diversity-related issues, including the working

environment of women in Jordan, issues of equal pay, gender prejudice, the expectation of staying home once married, etc.
