Strategies in meeting the assurances above include: Regular collaboration with local school districts. NWOSU's advisory board is made up of current public school partners, and our Teacher Education Committee has P12 stakeholders as voting members. We also receive first-year administrator survey data from the state regarding administrator feedback on first-year teacher preparation. NWOSU holds an education career fair every semester where schools are able to recruit NWOSU teacher candidates. This also allows us as faculty to stay current on the employment trends. Special education teachers must complete a 4x12 requirement in their general education core classes (12 hours of science, 12 hours of social science, 12 hours of math, and 12 hours of English/communication). All education majors take Students with Exceptionalities to ensure they are prepared to provide instruction to all students. All education majors must also meet a foreign language requirement for certification. Spanish for ESL Pedagogy meets this

state requirement. Diverse field experiences from entry-level courses to student teaching ensure candidates are prepared to meet the needs of all learners in a variety of settings.

A required course for all education majors is specifically designed to address the recognition and subsequent learning strategies for individuals who meet IDEA guidelines. Parents of children with special needs are guest speakers in classes, as are professionals from teaching associations, who discuss the importance of teaching students with disabilities. Mock IEP meetings are conducted in which candidates role-play certain parts of the meeting, along with faculty, to allow students to experience the importance of each role in the IEP process. Lesson and unit plans developed by candidates must include instructional strategies for those with disabilities and those who have limited English proficiency. Field experiences include classrooms in which there are students with disabilities and limited English proficiency

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

As cited in section 1.a. - All education majors take a course in which IDEA guidelines are taught. Education majors learn to develop IEP's and discuss the implications of the document.

All education majors take a course in which they learn how to work with students who have limited English proficiency. Instructional strategies for working with students who have limited English proficiency are interwoven throughout various methods courses in all content major coursework. A new course was designed in collaboration with another department to address Spanish for ESL pedagogy. Students will be prepared to effectively teach Spanish speakers in a variety of school contexts.

Candidates preparing for a special education degree have extensive training in completing the paperwork required for an IEP and the role of the special education teacher in this team.
