

SECTION 7: MASTER OF SCIENCE IN GENERAL PSYCHOLOGY DEGREE

GOALS

The goal of the Master of Science in General Psychology (MGP) degree is to make a contribution to the supply of academically prepared graduates in the state of Oklahoma that will perform necessary duties in the field of behavioral sciences. More specifically, graduates will be prepared

1. To evaluate and utilize advanced knowledge and theories from psychology and related disciplines to identify, develop, and implement best practices in the Behavioral Sciences field.
2. To summarize and critique the psychology literature including core theories.
3. To demonstrate their understanding and ability to implement basic and applied research designs used to address psychological issues.
4. To engage in complex, evidence-based practice.
5. To communicate both orally and in writing at a level that is appropriate for professionals in the Behavioral Sciences field.
6. To demonstrate the ability to work ethically and effectively with diverse student populations.
7. To evaluate innovative approaches to mental health issues leading to holistic care for individuals, families, and communities.
8. To demonstrate critical thinking and accountability related to behavioral sciences.

ADMISSION TO THE PROGRAM

In addition to the graduate office admission requirements listed in section 3 of this catalog, applicants must also meet the following additional requirements in order to be accepted into the Master of Science in General Psychology degree:

Admission Requirements:

1. Baccalaureate degree with at least 12 credit hours in psychology or related field from an accredited program.
2. An overall grade point average of 3.0 on a 4.0 scale in the last 60 hours of courses required for the undergraduate degree.
3. Completion of an undergraduate or graduate course in descriptive or inferential statistics with a grade of C or better.
4. Completion of an undergraduate or graduate course in research methodology with a grade of C or better.
5. Application may be made for conditional admission by students having an overall undergraduate GPA of at least 2.50 with no more than ten years having passed since the completion date of the required psychology credit hours.
6. Students with a native language other than English must submit evidence of English language proficiency. Evidence may include (1) completing a four-year bachelor's degree from a U.S. institution or the equivalent in your home country; (2) students meeting the English language requirements of an official TOEFL score (520 for a paper-based test, 190 for a computer-based test, or 68 for an internet-based test) or IELTS score is required for all students for whom English is a second language. The TOEFL must have been taken within the last two (2) years.
7. Submission of completed Program Application with personal statement.
8. Submission of three (3) letters of recommendation attesting to academic ability, professional competency,

and personal character.

9. Submit a written statement of career aspirations and a self-evaluation of strengths and weaknesses related to the field of study.
10. Submit a sample of scholarly written work (e.g., a research paper, term paper, professional report, or publication).
11. A score that places the individual At the 25th percentile or higher on two of the three areas (verbal, quantitative, and analytical writing) of the Graduate Record Exam (GRE) or at the 25th percentile or higher on the Miller Analogies Test (MAT). **Note:** Students who plan to pursue a doctoral degree are urged to take the GRE.
12. Complete an interview with psychology department graduate faculty.
13. Application and acceptance to NWOSU and the Office of Graduate Studies.

ACADEMIC RETENTION

Retention Standards:

1. Student must file a plan of study, signed by both the student and members of the advisory committee, by the end of the first semester of graduate work.
2. Student must maintain a cumulative GPA of 3.0 or higher. Students whose cumulative GPA falls below 3.0 at any time will receive a letter of academic warning and will meet with their academic advisor to develop a personal plan for improvement.
3. Student must be enrolled in a minimum of one course per semester (summer optional) and is normally expected to complete all of the degree requirements within six years after admission to the program.

GRADUATION STANDARDS

The following standards must be met before graduating:

1. Successful completion of all curricular requirements.
2. MS in General Psychology candidates will either present a research project or submit a thesis for publication.
3. MS in General Psychology candidates for graduation must successfully defend their Capstone Project or Thesis according to guidelines developed by the Psychology Department and approved by the Graduate Committee.
