Co-Curricular Learning

The 2025 Co-Curricular Learning survey examined ethical leadership, service, fiscal responsibility, and critical thinking. NWOSU strives to teach students about these four key elements not only in the classroom, but during co-curricular activities as well.

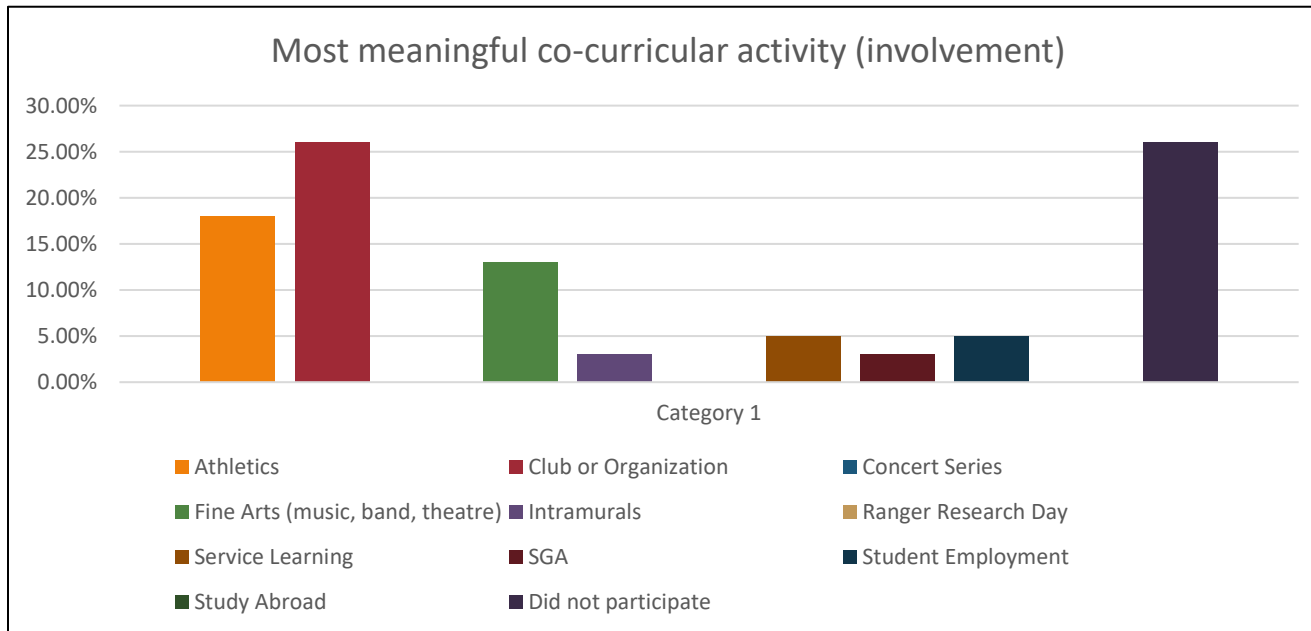
Participants

The survey was made available to all Northwestern Oklahoma State University (NWOSU) students. There were 38 students who completed the survey. Of the participants, 16% were freshman, 13% were sophomores, 34% were juniors, 26% were seniors, and 11% were graduate students. The participants consisted of 84% female, 11% were male, and 5% identified as other. The participants were made up of the following races: American Indian (5%), African American (5%), Caucasian (79%), Hispanic (11%), and Native Hawaiian or Other Pacific Islander (0%).

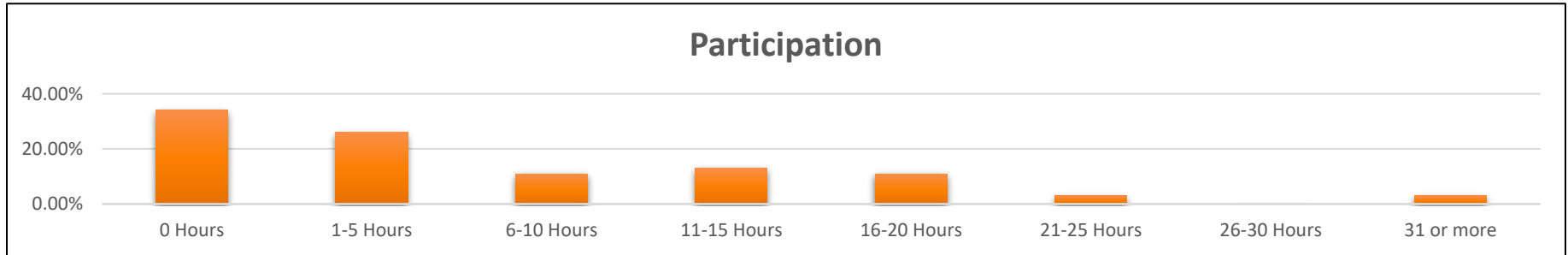
Involvement

The chart to the left reflects what students reported to be the most meaningful co-curricular activity in which they had participated since becoming an NWOSU student.



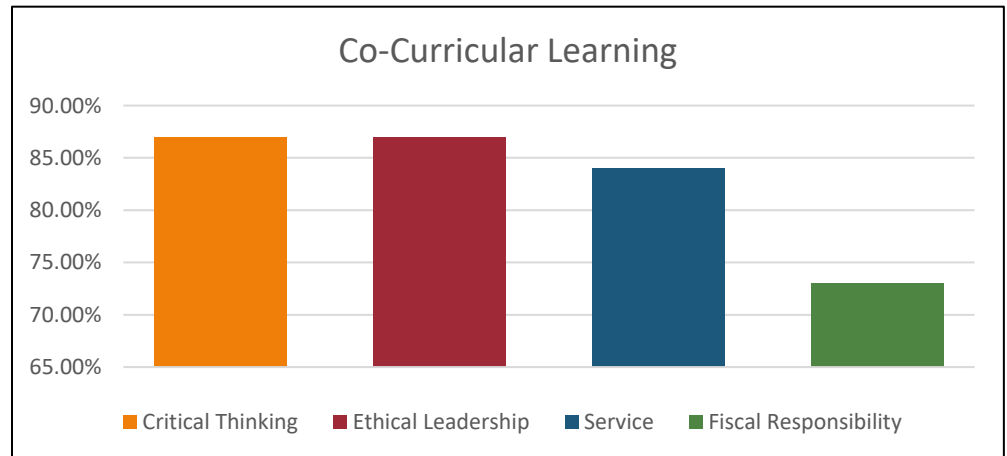
Co-Curricular Participation

Participants were asked how many hours they participated in co-curricular activities. Overall, 34% did not participate in co-curricular activities, 26% participated in 1-5 hours, 11% participated in 6-10 hours, 13% participated in 11-15 hours, 11% were involved in 16-20 hours, 3% participated in 21-25 hours, 0% participated in 26-30, and 3% participated in 31 or more. Co-Curricular Learning

The chart to the right shows the percentage of students answering “very likely” or “likely” when rating the likelihood of learning about critical thinking, ethical leadership, service and fiscal responsibility in various co-curricular activities in which they participated.



Examples

Below are a few examples of activities or situations that took place when students were taught more about the following:

- *Critical Thinking:* Playing an instrument, learning about the court system, giving presentations, soccer practice, planning events, and character analysis.
- *Ethical Leadership:* Being a part of a team, learning ANA code of ethics, traveling for events, setting up a Halloween event, and Theatre.
- *Service:* Required volunteer hours, helping at the Pumpkin Patch, being a part of a club and organization, and putting up Christmas lights for Alva.
- *Fiscal Responsibility:* Fundraising for club trips, athletic budgets for traveling, purchasing items for costume designing, and buying materials for plays.
