The math education program coordinator recruits individuals to the mathematics education program when students enroll in college algebra. Campus career and job fairs allow students to view high demand areas from regional school districts. Introductory education courses emphasize high need areas including mathematics. Mock IEP meetings are conducted in which students role-play certain parts of the meeting along with faculty to allow students to experience the importance of each role in the IEP process.
