Alumni Highlight-Sarah Thompson

"As a social worker, I have had the opportunity to make a difference and grow as a professional," said Northwestern Oklahoma State University (NWOSU) Social Work alum, Sarah Thompson. "I am proud to be among such an outstanding group of professionals as a Licensed Clinical Social Worker in Oklahoma. It is an honor to be able to contribute to social justice and change."

Thompson received her Bachelor of Science from NWOSU in 2004, then returned to NWOSU to complete her Bachelors of Social Work in 2011. After graduating from NWOSU in 2011, Thompson began her social work career with Opportunities Inc. Head Start. While there, she began working as a family advocate, working directly with low income children and their families, providing case management services to assure that all families received comprehensive care.

"The Head Start program gave me the opportunity to advocate for individuals as well as address social problems that directly impact children and families," said Thompson.

She then left Opportunities, Inc. and began working for the Oklahoma Department of Mental Health and Substance abuse Services (ODMHSAS) as a Prevention Specialist. There, she developed community coalitions to address substance abuse issues at the macro level.

As she began to expand her practice, she began working for Western Plains of Youth and Family Services' (WPYFS) Systems of Care program. While at YFS she provided services to children with mental health challenges and their families.

Following her time at WPYFS, Thompson, began working as a school based social worker through a partnership between Woodward Public Schools and the Department of Human Services. As a school based social worker she worked with teachers, parents, community agencies, and other professionals to address student problems and develop appropriate intervention strategies. She was also the homeless liaison for the school district.

After receiving her Masters in Social Work from the University of Oklahoma in 2013, she began working for Youth and Family Services of North Central Oklahoma. She provided therapeutic counseling to school-aged children ranging from ages 4 - 18. After leaving Youth and Family Services, Thompson worked at Millennium Community Services, where she provided outpatient counseling to adults and children. In addition to working in an outpatient setting, she worked with Faith Hospice to assist patients living with terminal conditions. She arranged for care to enhance the quality of life and counseled patients and their families as they adjusted to the diagnosis.

"My experiences with hospice, school-based counseling, and outpatient therapy provided me with the opportunity to be exposed to a variety of populations at all stages of life. During

Rehder recognized by University of Oklahoma School of Social Work



Dr. Kylene Rehder, an associate professor, director of the Social Work Program and chair of the Department of Social Work at Northwestern Oklahoma State University, was chosen as one of 100 honorees in the field of social work from the Anne and Henry Zarrow School of Social Work at the University of Oklahoma during the school's 100 for the 100th anniversary celebration.

Rehder has worked at Northwestern since 2005 and is credited with leading the social work program to external accreditation by the Council on Social Work Education (CSWE). Northwestern's social work program is only one of five CSWE accredited universities in the state and is the only one in western Oklahoma. With the development of a social work program in the region, the landscape of social services in Northwest Oklahoma has been transformed.

The honorees were social workers, former faculty, directors, alumni and other friends and supporters of the school. The anniversary celebration culminated in a very special dinner event: "An Evening of Celebration: 100 Years of Social Work" on Friday, Sept. 15, 2017, in the University of Oklahoma Molly Shi Boren Ballroom.

Rehder was beyond thrilled to be included as one of the 100 for the 100th anniversary celebration, particularly because she understands the brilliant and dedicated social workers this state has.

"I am truly humbled by this honor because our state encompasses so many brilliant and dedicated social workers who work tirelessly to enhance human well-being," Rehder said. "It is a dream come true to

chair the Department of Social Work at Northwestern as it is

where I originally developed my passion in social work and my commitment to help meet the basic needs of all people. It is a privilege to work as a professional social worker, and having your contributions recognized by the University of Oklahoma's Anne and Henry Zarrow School of Social Work and your alma mater is a wonderful professional experience."

The 100 selected individuals were honored in two main ways. The first included a year-long tribute on the school's website that will showcase those selected with a photo and short biography. The second was at the 100th anniversary event in September.

Rehder obtained a bachelor's degree in social work from Northwestern (2001) and a Master of Social Work from the University of Oklahoma (2003), graduating summa cum laude. In 2013, she completed a doctorate

degree from North Central University, where her dissertation research focused on the use of technology in social work education and practice.

Rehder is a Licensed Clinical Social Worker and a Board Approved Clinical Supervisor by the Oklahoma State Board of Licensed Social Workers. She has a rich history of involvement in the

Branch Chair, Chapter Committee on Leadership Identification (CCNLI), steering committee for the Social Work Public Education Campaign, and a member of the Political Action for Candidate Election (PACE) committee.

CWPEP stipend awarded to two social work majors

Northwestern Oklahoma State University's Department of Social Work announces Northwestern-Woodward junior Marsellia Rael and Northwestern-Enid junior Denise Tyrell are the stipend recipients of the Child Welfare Professional Enhancement Program (CWPEP) for the 2017-2018 academic year.

CWPEP provides funds for students who plan careers in child welfare services in Oklahoma. The stipends are awarded to full-time students majoring in social work and provide money toward educational expenses to participating students. Students who receive the stipends complete educational internships in child welfare agencies within the Oklahoma Department of Human Services (OKDHS). Upon graduation, students are assured employment in the participating DHS programs.

"I am majoring in social work because there is nothing better than helping children, who are going to be the future of tomorrow," Rael said. "I'm lucky enough to be a recipient of the CWPEP and plan on utilizing my education to help families and children improve their lifestyles and bring opportunities to them."

Denise Tyrell said, "My reason for choosing a social work degree, and more specifically Child Welfare, is because I want to make a difference in someone's life. I want my career to have purpose, and I feel like Social Work is the best way to fulfill that. As a Child Welfare specialist, I hope to be an advocate for children and families. I intend to use what I learn during my studies at Northwestern to further this goal."

"The social work program is proud to administer the CWPEP program and play an essential role in securing and *retaining quality social workers in the public child welfare system*," Dr. Kylene Rehder, Department of Social Work Chair, CWPEP coordinator, and associate professor of social work said. "CWPEP at Northwestern has graduated 15 students, resulting in more than \$115,000 being awarded in educational assistance."

CWPEP is a Title IV-E partnership between the University of Oklahoma, the Oklahoma Department of Human Services, the US Department of Health and Human Services Administration for Children and Families Council, and Social Work Education (CSWE) in accredited social work programs in Oklahoma. The University of Oklahoma manages the child welfare consortium. Other partners along with Northwestern include East Central University and Oral Roberts University.

Funding for the educational program is provided by Title IV-E of the social security act, called the Child Welfare Training program.



Kausek awarded scholarships; new scholarship added to program

Dana Kausek, senior from Enid, has been awarded the Ruth Ann Devery VanLandingham and Steve and Janet Valencia scholarships for the 2017-2018 academic year. Together, the two scholarships totaled almost \$500.

"I feel truly honored to be selected as the VanLandingham and Valencia scholarship winner," said Kausek. This gives me pride in knowing that my determination and hard work as a social work student at Northwestern Oklahoma State University has been meaningful to someone other than myself. Thank you for the opportunity and I look forward to continuing my path to educational success!"

The Ruth Ann Devery VanLandingham ('80) scholarship was named for the wife of Ted VanLandingham and her children after she passed in an automobile accident in 1991. VanLandingham graduated from Northwestern Oklahoma State University with a BA degree in Social Work. VanLandingham was employed as a social worker for the Achenbach Center in Hardtner, KS and then at Parkview Learning Center at Macksville, KS.

Students receiving this scholarship must be an upper-division, full-time student majoring in social work. They must have a minimum of a 3.0 cumulative GPA with preference going to a non-traditional student who demonstrated financial need.

Steve ('88) and Janet ('87) Valencia, Alva, added to the department's scholarship program during the spring of 2017 to assist social work students with the expenses of college life. This stipend can be applied to the student's account for tuition and fees, books, and/or room and board. The scholarship stipulates that the award must go to a full-time, continuing social work student with a cumulative GPA of at least 2.5.

"Steve and I felt that a nationally accredited program should have more than just one scholarship. We've known Kylene for a long time and she has worked hard to build her program. We wanted to show her that we noticed. This small token was our way of showing our appreciation to these hard working students who will give their lives to the social work profession," said Janet.

that time, I gained valuable insight and skills,” said Thompson. “I learned to appreciate the resiliency and strengths of our most underserved and oppressed populations. There is no one you can’t learn to love once you’ve listened to their story.”

In addition to her regular social work practice, Thompson, teaches part time as an adjunct instructor for the NWOSU Social Work Department.

After completing her LCSW, she began working as a geriatric social worker with Millennium Medical Services where she is currently employed. In her current position, she provides therapy to the elderly population in a nursing home setting.

“I am honored to work with our elderly population. I provide therapy and support to help them cope with the challenges they are experiencing,” said Thompson.

“I love this field and would encourage anyone with the desire to make a difference to explore social work as a career choice.”

Thompson has participated as a CASA volunteer and has served as a foster and adoptive parent in her community. Thompson is actively involved in community through Feed the Neighborhood and volunteers as a youth sports coach. Thompson also writes a column for the Enid News and Eagle.

Thompson has one daughter, Allison, who is 15-years-old. She also has a chocolate Lab named, Brady, whose goal is to one day be used as a therapy dog in nursing homes.

Her research efforts on licensure laws, titles and requirements provided the necessary foundation for

legislative changes, bringing the Oklahoma’s Social Work Practice Act in alignment with other jurisdictions and the Social Work National Model Act. In 2015, Rehder was appointed by the governor to serve on the State Board of Licensed Social Workers and is currently the board’s secretary. She is an advisory board member for the Child Welfare Professional Enhancement Program (CWPEP), which focuses on strengthening child welfare services in

Oklahoma. In addition, she is a board member of Freedom West Community Development Corporation, a non-profit development entity in Northwest Oklahoma that works to revitalize rural communities to increase community sustainability through proactive social and economic change efforts. Freedom West CDC was

awarded Social Services Organization of the Year in 2016 by NASW-OK.

Rehder serves as a clinical consultant to many Northwest Oklahoma agencies and is a member of the Oklahoma Medical Reserve Corps (OKMRC), where she serves as a disaster mental health responder. She is the Jake and Jayne Lindsay Endowed Chair in Social Work at Northwestern and was awarded the university’s Distinguished Service Award in 2012. In 2013, she was named the prestigious John Barton Distinguished Teaching and Service Award recipient.
